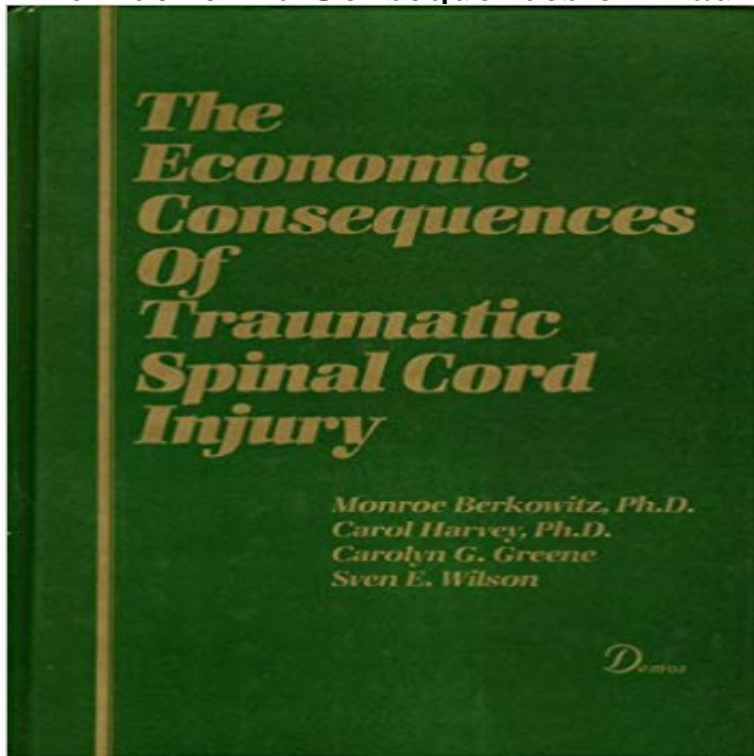


# The Economic Consequences of Traumatic Spinal Cord Injury
