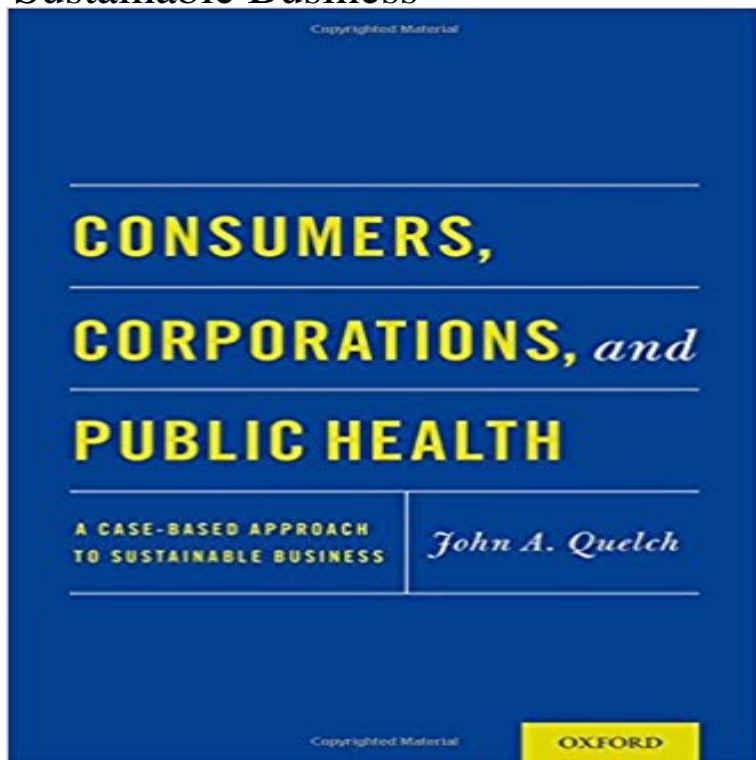


Consumers, Corporations, and Public Health: A Case-Based Approach to Sustainable Business
