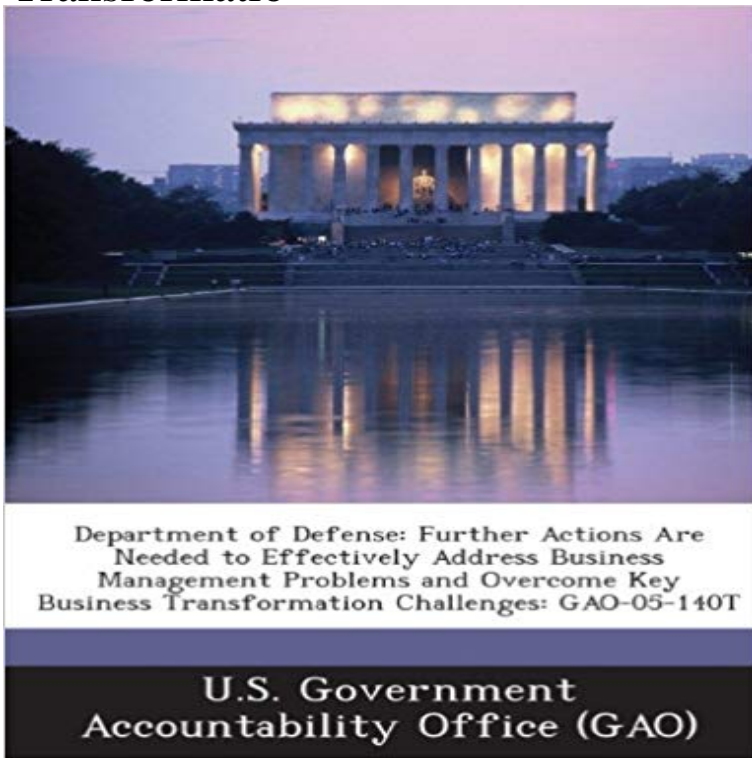


Department of Defense: Further Actions Are Needed to Effectively Address Business Management Problems and Overcome Key Business Transformation
