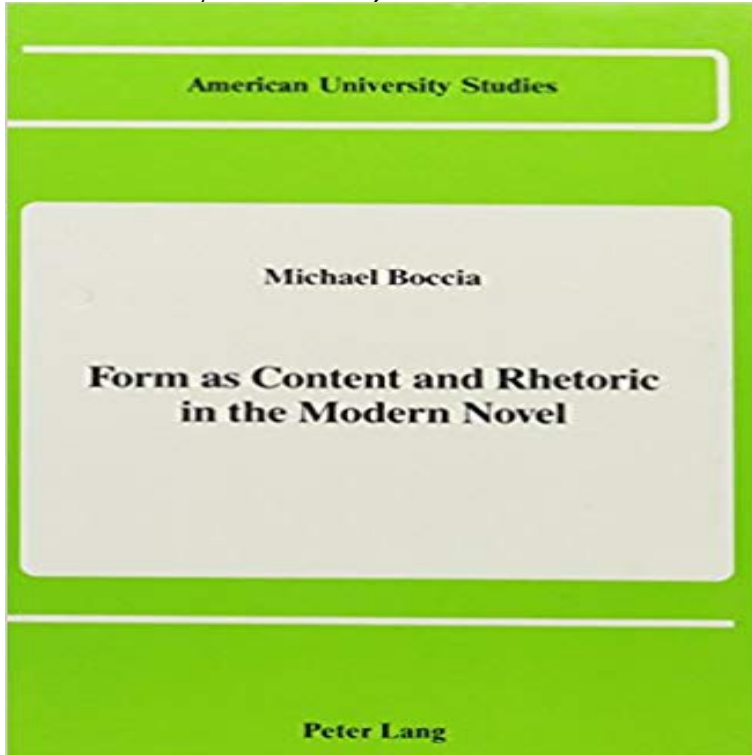


Form as Content and Rhetoric in the Modern Novel (American University Studies)
