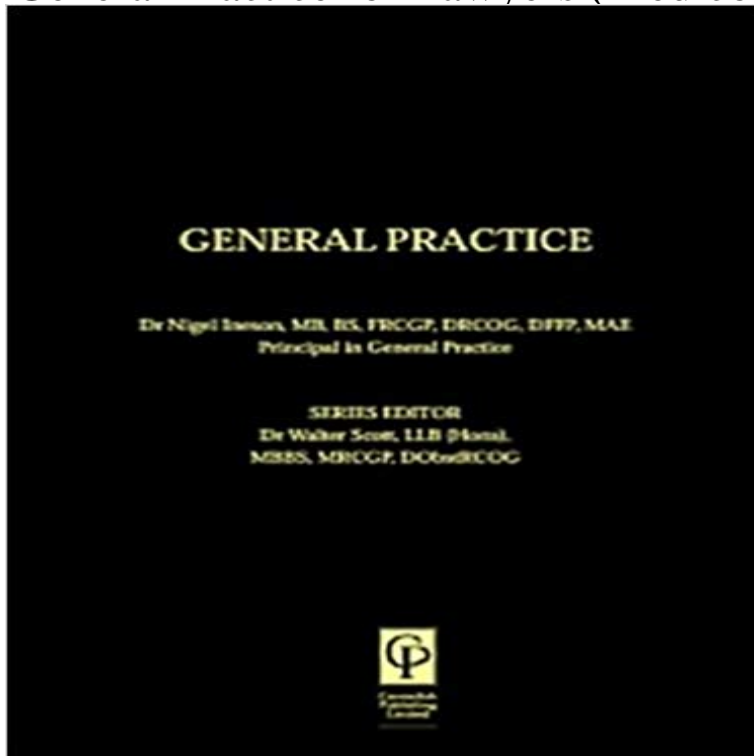


General Practice for Lawyers (Medico-Legal Practitioners)
